 - Motion: Amend the policies and procedures as follows: "SPMS is to keep a 3 month reserve of liquid assets at all times in the eventuality of dissolution. The reserve amount will be composed of any fixed and/or contractual expenses, and any accounts payable at that time. This includes, but is not limited to, professional fees, legal and/or administrative expenses, credit card balances, or any other accounts or bonds payable. The SPMS Treasurer will, on a quarterly basis, compute and disclose the current reserve amount for that quarter. Should the amount of liquid assets fall below this reserve, the SPMSC must approve any and all monetary distributions until either the policy is amended, or sufficient liquid assets be re-established to satisfy the reserve condition."
