- Coaches Membership Renewal

Currently USMS certified coaches pay an additional \$30 per year with their annual membership fee to maintain their "Certified Coach Designation Status". For example, in 2018 for SPMS certified coaches, the membership renewal totaled \$91 (\$30 coach designation fee and \$61 membership fee).
