## Working on SP SCM Records (once T10 review is finished).

### Issues:

- (1) 200 SCM BA record for Ellen Reynolds denied by FINA. CTS failed on last 50 of the 200 SCM Back, resulting in unuseable pad and pickle (backup) times. USMS record accepted based on 3 watches, but WR denied because watch times may not be used.
- (2) Handling of declaration of intent forms for NSG; worked with Kenny to get this resolved
